(H) CONDITIONS OF LICENCE

- (1) This licence is granted in reliance on the information provided and declared by the licensee on the application under the stated Application Reference No. Provision of false information or making false declaration in the said application shall render this licence null and void. Heavy penalties are provided for false declaration and information, unauthorised alterations of the licence and use of forged or altered licence.
- (2) A breach of any of the conditions of licence imposed by the Director-General of Trade and Industry may render this licence to be cancelled, revoked or suspended in addition to other appropriate legal and/or administrative actions to be taken against the entities concerned.
- (3) The goods covered by this licence are not to be used in relation to nuclear, biological or chemical weapons or missile capable of delivering these weapons.
- (4) In case the goods covered by this licence is not for the importer's own use but is to be further transferred, the importer should ensure that the recipients of the goods are duly informed of all the conditions of the licence.
- (5) The importer should take appropriate precautionary measures to ensure that the goods covered by this licence will only be used by or transferred to civil end-users for civil end-use. Prior approval from the Director-General of Trade and Industry is required if the goods covered by this licence are not for civil end-use.
- (6) This licence only authorises import of the goods. Re-export must be covered by an export licence issued by the Director-General of Trade and Industry if the goods fall under the control of the Import and Export (Strategic Commodities) Regulations at the time of export.
- (7) For in-transit cases, the goods must remain on board at all times while in Hong Kong unless directed by the Commissioner of Customs and Excise or his authorised officers.
- (8) If the arms and ammunition covered by this licence also fall under the control of the Firearms and Ammunition Ordinance (Cap. 238), the validity of this licence is subject to the issue of a valid licence for possession or dealer's licence by the Hong Kong Police Force.
- (9) This licence allows part shipments. In case of part shipments, the importer must provide correct shipment arrival details on this licence and must not take delivery of the goods until such information has been endorsed by the carrier. Written declaration [TID 352] should also be completed and passed to the carrier. When the balance of the consignment covered by the licence is imported, the original of the licence must be given to the shipping, airline or transportation company.
- (10) The original of this licence shall be the only valid copy against which the carrier may release the goods described herein to the importer on arrival in Hong Kong unless special authority to permit release of such goods against a certified true copy is granted by the Director-General of Trade and Industry or an officer authorized by him. The carrier should check details given by the importer and return the licence or written declaration in the case of part shipments to Trade and Industry Department together with the relevant manifest.
- (11) The importer must lodge import declarations with the Commissioner of Customs and Excise in respect of items on this licence within 14 days of shipment.
- (12) This licence is issued to the importer for his use to import goods covered by this licence and is **NOT TRANSFERABLE**.
- (13) All or any of the information in this licence may be disclosed by Trade and Industry Department in any particular in Hong Kong or elsewhere provided that such disclosure is in the public interest.
- (14) The Director-General of Trade and Industry reserves the right to impose additional conditions on the licence as he sees fit in the public interest. Such additional conditions may be promulgated in circulars and notices issued by Trade and Industry Department.

Special Condition(s) :

- (1) The importer should make arrangements with the Customs and Excise Department, at least 3 days in advance, for physical examination of the goods covered by this licence at a Customs Control Point, i.e. upon the goods subsequent return to Hong Kong.

- (2) The importer should present the goods covered by this licence to Customs officers at a Customs Control Point, i.e. upon the goods subsequent return to Hong Kong for -
a. physical examination of the goods; and
b. certification on the original and duplicate of this licence of the results of the physical examinations.
在貨品輸入香港時，進口商必須在海關管制站向香港海關人員出示本證所載列的貨品，以便海關人員：
a. 實地檢查貨品；以及
b. 在本證的正本和第一副本上註明驗貨結果。
- (3) Unless and until the goods covered by this licence have been physically examined by Customs officers and the results of such examination are certified on this licence as required by Condition (2) above, the importer should not make possession of the goods after they have been temporarily exported out of Hong Kong.

- (4) The importer should, within 2 days after the goods have returned to Hong Kong, submit in person a letter reporting the return of the goods together with the duplicates of this import licence and the export licence by which the goods were temporarily exported out of Hong Kong, both bearing Customs certification of examination results, to the Licensing Section of the Strategic Trade Controls Branch of Trade and Industry Department and obtain their acknowledgement of receiving all these documents.
進口商須在貨品運返香港後三天內，親帶人向工業貿易署戰略貿易管制科簽證組遞交信件（呈報貨品已運返），並須一併遞交註有香港海關驗貨結果證明的進口證及用以暫時輸出貨品的出口證之第一副本。進口商須向簽證組取回認收進口商信件及有關許可證副本的收據。
- (5) The original of this licence is to be returned to Trade and Industry Department by the shipping company, airline company or transportation company together with the manifest in accordance with the Import and Export Ordinance. The duplicate of this licence is to be returned to Trade and Industry Department in accordance with Condition (4) above.

- (6) No further re-export, resale, transfer, or disposal of the goods without prior notice to and approval from the Director-General of Trade and Industry.
