The carrier must check details in (a) to (e) against Bill of Lading/Air Waybill and manifest and sign under (g) to confirm that checking has been done. At the same time, the importer is required to complete a written declaration for part shipments (SC 014) and hand it over to the carrier who will submit it to Trade and Industry Department together with the manifest. For valid licences in which there is still balance in the licence quantity, the carrier may return the original of this licence to the applicant for further use until its quantity is exhausted or the licence has expired, in which case the carrier should collect the licence and return it together with the manifest to Trade and Industry Department.
