## (H) CONDITIONS OF LICENCE

- (1) The goods covered by this licence must be shipped at the same time on the same vessel, aircraft or vehicle.
- (2) This licence is granted in reliance on the information provided and declared by the licensee on this application and the relevant Approval-in-Principle Agreement which is still valid at the time of application as granted by the Trade and Industry Department. Provision of false information or making false declaration shall render the licence null and void. Heavy penalties are provided for false declaration and information, unauthorized alterations of the licence and use of forged or altered licence.
- (3) A breach of any of the conditions of licence and the conditions in the relevant Approval-in-Principle Agreement imposed by the Director-General of Trade and Industry may render this licence to be cancelled, revoked or suspended in addition to other appropriate legal and/or administrative actions to be taken against the entities concerned.
- (4) The goods covered by this licence are not to be used in relation to nuclear, biological or chemical weapons or missile capable of delivering these weapons.
- (5) The exporter is required to inform the recipients of the goods of all the conditions of this licence.
- (6) The exporter should take appropriate precautionary measures to ensure that the goods covered by this licence will only be used by or transferred to civil end-users for civil end-use. Prior approval from the Director-General of Trade and Industry is required if the goods covered by this licence are not for civil end-use.
- (7) The goods previously imported into Hong Kong may be subject to re-export control by the government(s) of the products' foreign exporting/originating country (place). Exporters should check with the manufacturer/foreign exporter of the goods to ensure that there is a valid re-export authorisation issued by the government(s) of the products' foreign exporting/originating country (place) concerned to cover the subject export.
- (8) For in-transit cases, the goods must remain on board at all times while in Hong Kong unless directed by the Commissioner of Customs and Excise or his authorised officers.
- (9) If the arms and ammunition covered by this licence also fall under the control of the Firearms and Ammunition Ordinance (Cap. 238), the validity of this licence is subject to the issue of a valid licence for possession or dealer's licence by the Hong Kong Police Force.
- (10) The original of this licence must be given to the shipping, airline or transportation company for return to Trade and Industry Department with the relevant manifest.
- (11) The exporter must lodge export declarations with the Commissioner of Customs and Excise in respect of items on this licence within 14 days of shipment.
- (12) This licence is issued to the exporter for his use to export goods covered by this licence and is NOT TRANSFERABLE
- (13) All or any of the information in this licence may be disclosed by Trade and Industry Department to third parties either in Hong Kong or elsewhere provided that such disclosure is in the public interest.
- (14) The Director-General of Trade and Industry reserves the right to impose additional conditions of licence as he sees fit in the public interest. Such additional conditions may be promulgated in circulars and notices issued by Trade and Industry Department.

### Special Condition(s) :

- (1) This licence only authorises export to the stated consignee for civil end-use by the end-user as stated on the licence. Any change of end-use or end-user, or further re-export, resale, transfer, or disposal of the goods is subject to the authorisation of the original exporting government.
