These articles may need to be covered by licences, permits or certificates issued by the relevant Government departments and subject to the terms and conditions imposed. Examples of such articles are **Controlled Chemicals, Outboard Engines exceeding 111.9 Kilowatts (150 Horsepower), Ozone Depleting Substances, Pesticides, Pharmaceutical Products, Medicines and Dangerous Drugs, Radio Transmitting Equipment, Radioactive Substances/ Irradiating Apparatus** etc..
